W&OD Trail users will be redirected to a VDOT-approved detour while Dominion Energy replaces electric transmission lines along the trail

WHERE

Town of Vienna, Mill St NE to Sandburg St (Mile Markers 9-12)

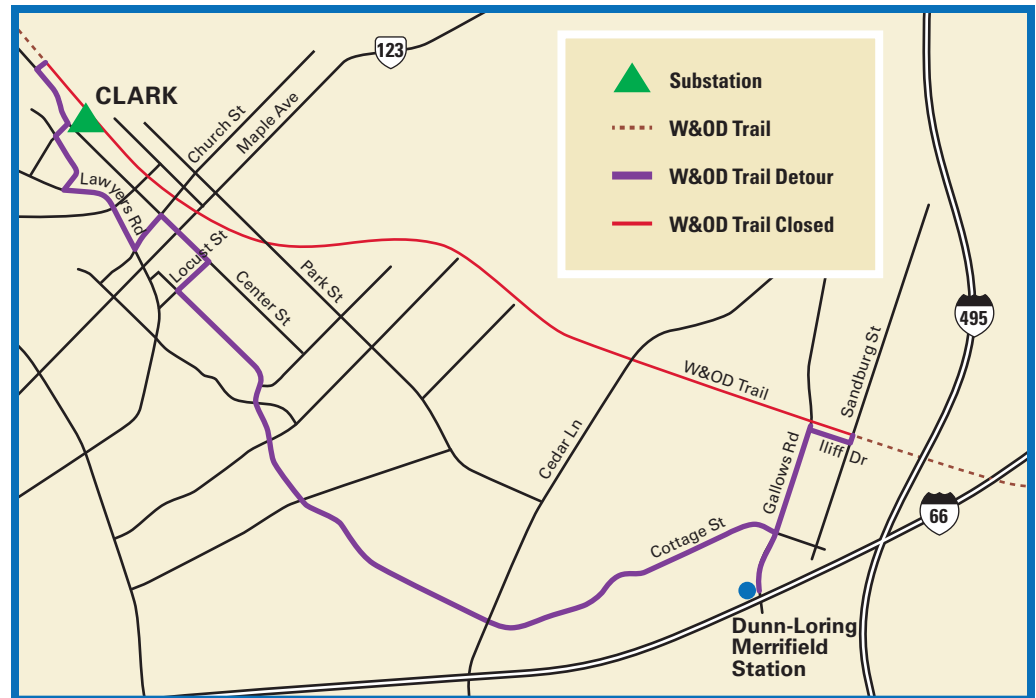
WHEN

November 11–15, 2024 (dates subject to change)



DETOUR MAP

Trail length: 2.8 miles | Detour length: 4.8 miles



EASTBOUND TOWARD FALLS CHURCH

From W&OD Trail, turn right toward Mill St NE
 In 200 ft, turn left onto Center St N
 In 0.2 miles, turn right onto John Marshall Dr NW
 In 0.2 miles, turn left onto Lawyers Rd
 In 0.5 miles, turn left onto Church St NW
 In 0.2 miles, turn right onto Center St N
 In 0.2 miles, turn right onto Locust St SW
 In 0.1 miles, turn left onto Cottage St SW
 In 2.7 miles, turn left onto Gallows Rd
 In 0.4 miles, cross Gallows Rd at W&OD Trail intersection, then turn right to proceed south on Gallows Rd
 In 200 feet, turn left onto Iliff Dr
 In 0.1 miles, turn left onto Sandburg Street
 In 200 feet, turn right to rejoin W&OD Trail

WESTBOUND TOWARD RESTON

From W&OD Trail, turn left onto Sandburg St
 In 200 ft, turn right onto Iliff Dr
 In 0.1 miles, turn right onto Gallows Rd
 In 200 ft, at the W&OD Trail intersection, cross Gallows Rd and then turn left to proceed south on Gallows Rd
 In 0.4 miles, turn right onto Cottage St
 In 2.7 miles, turn right onto Locust St SW
 In 0.1 miles, turn left onto Center St S
 In 0.2 miles, turn left onto Church St NW
 In 0.2 miles, turn right onto Lawyers Rd NW
 In 0.5 miles, turn right onto John Marshall Dr NW
 In 0.2 miles, turn left onto Center St N
 In 0.2 miles, turn right onto Mill St NW
 In 200 ft, turn left to rejoin W&OD Trail

Dunn Loring-Merrifield Station/I-66 Trail to W&OD Trail Detour

Eastbound: Proceed north on Gallows Rd through Cottage St intersection, then follow detour route to rejoin W&OD Trail at Sandburg St

Westbound: Proceed north on Gallows Rd, then turn left on Cottage St to follow detour route

W&OD Trail Detour to Dunn-Loring Merrifield Station/I-66 Trail

Eastbound: From Cottage St, turn right onto Gallows Rd

Westbound: Continue south on Gallows Rd through Cottage St intersection
