

Dominion Energy Virginia Notice of Nonparticipation Form

For Large General Service (LGS) Customers

(Exemption from Energy Efficiency Rate Adjustment Clause in Virginia)

This form may serve as the Notice of Nonparticipation prescribed by State Corporation Commission Rules Governing Exemption for Large General Services Customers (20VAC5-350). Use of this form is not required; the form is offered by Dominion Energy Virginia for guidance as a courtesy to its customers.

To be eligible for an exemption from an energy efficiency rate adjustment clause a customer must 1) have verifiable history of more than one megawatt of monthly demand from a single site, in any single billing month, during each of the previous three calendar years*; and 2) certify to the Commission that it has implemented energy efficiency programs, at the customer's expense, that have produced measured and verified results within the prior five years.

It is the sole responsibility of the customer to ensure that it meets the requirements of regulation 20VAC5-350 when seeking an exemption.

Customers whose Notices are accepted will be exempt from energy efficiency rate adjustment clauses and will therefore be ineligible to participate in Dominion Energy Virginia's energy efficiency programs.

All notices of nonparticipation must be filed concurrently by the customer with the State Corporation Commission's Division of Public Utility Regulation:

The Notice and all supporting documentation must be received by Dominion Energy Virginia by March 1 to be considered for the applicable year.

Following receipt of the Notice, Dominion Energy Virginia will either:

- 1) notify the customer that this Notice is accepted; or
- 2) notify the customer that this Notice is deemed deficient and is, therefore, not accepted.

Dominion Energy Virginia's acceptance or denial of any Notice of Nonparticipation will concurrently be sent to the customer and provided by the utility to the State Corporation Commission's Division of Public Utility Regulation.

Upon acceptance of any Notice of Nonparticipation, that customer shall be exempt from any Dominion Energy Virginia rate adjustment clause approved by the State Corporation Commission pursuant to § 56-585.1 A 5 c of the Code of Virginia, beginning with the effective date of the next rate adjustment clause following the date of acceptance of the Notice of Nonparticipation and continuing throughout the life of the customer's energy efficiency improvements described in the customer's Notice of Nonparticipation. If a Notice is determined to be deficient, the customer must wait until the following year to be eligible for the exemption and re-submit the Notice with the deficiencies addressed.

* Customers with highest measured demands from a single site of more than one megawatt in any single billing month, if such customers do not have three calendar years of history, will satisfy the demand portion of eligibility.

Other Requirements:

- Include with this form an **affidavit** signed by the customer's president, corporate secretary, or other officer of the customer concerning the energy efficiency programs. Such affidavit shall attest to the validity of the information submitted in support of the customer's notice of nonparticipation, and that energy savings claimed on this form meets the definition of measured and verified as set forth in §56-576 of the Code of Virginia.

Include with this form a Measurement and Verification Plan that conforms to the protocol set forth in the definition of "measured and verified" as provided in §56-576 of the Code of Virginia. It shall be the customer's sole responsibility to ensure its Measurement and Verification Plan conforms to this definition. Generally, an M&V Plan includes methodologies/protocols for determining the energy savings for each energy efficiency measure identified by the customer in the Energy Efficiency Information section of the Notice of Nonparticipation. This should include how values used in calculations are measured or otherwise determined. (Savings will be the net difference in energy usage of the original equipment and the replacement equipment.)

Going Forward:

- The customer shall subsequently furnish yearly reports to Dominion Energy Virginia and the State Corporation Commission's Division of Public Utility Regulation. These yearly reports shall describe the energy efficiency savings achieved by the customer during each 12-month period in which such notice of nonparticipation is intended to be in effect. The annual reports shall include the status of energy efficiency measures and operational changes included in the customer's notice of nonparticipation. The customer shall certify that each such annual report demonstrates energy efficiency savings at a level consistent with commonly accepted industry standards for energy efficiency savings obtained by similarly situated customers and adheres to any other regulatory criteria the commission reasonably deems appropriate. The reports shall be filed on or about March 1 of the year following such customer's filing of its notice of nonparticipation, with such March 1 filings continuing thereafter throughout the life of the customer's energy efficiency improvements described in the customer's notice of nonparticipation.
